

TERMS OF USE

Thank you for visiting our website www.isgyo.com.tr ("Site" or "Website")

By visiting the Website, you declare that you have read and understood the terms and conditions contained herein and that you agree to be bound by the Terms of Use, regardless of your access and use method. If you do not accept the Terms of Use, you may not use the Website.

The terms "user" and "you" mentioned in the Agreement refer to persons using the Website. Such use can only occur by visiting the Site or creating a user account, regardless of the duration and frequency of visits. The terms "İş GYO (Is REIC)" and "we" in this Agreement refer to İş Gayrimenkul Yatırım Ortaklığı Anonim Şirketi.

IMPORTANT NOTE

Before reading the other terms and conditions of the Terms of Use, we would like to draw your attention to the following items.

The personal data you provide to us is subject to the relevant Policy, and by visiting the Website, you will be deemed to give explicit consent to the processing of your personal data under the Policy in connection with your use of the Website. Before continuing to use the Website, you can read the Personal Data Protection and Privacy Policy to learn how your personal data can be processed, how you can exercise your rights in this context, and how you can refuse or delete cookies and similar technologies.

Changes

İş GYO (Is REIC) may, at any time, change the Terms of Use or accept new terms and conditions by uploading the current terms and conditions to their website. If you continue to use the Site after the changes have been made, you agree to such changes. Therefore, in the event that you review the Terms of Use regularly and do not accept the changes made to the Terms of Use, you must terminate the use of the Website.

1. THE SCOPE OF THE TERMS OF USE

- 1.1. The Terms of Use regulate the terms and conditions regarding your use of the Website. Your visit to the Site, regardless of its duration and frequency, indicates that you have read, understood and agreed to be bound by the Terms of Use as of the date of your first visit to the Site.
- 1.2. In addition to the Terms of Use, İş GYO (Is REIC) may stipulate special terms and conditions to be applied to certain pages or features of the Website. In case you use such pages or features of the Website, it is assumed that you have read, understood, and accepted the special terms and conditions applicable to them. In case you do not accept the special terms and conditions mentioned, you must not use the pages and features of the Website.

2. USER ACCOUNT

- **2.1.** You can use the Website without opening a user account and logging in. However, accessing certain features or content offered on or through the Website may require you to open a user account and log in.
- **2.2.** The User accepts, declares and undertakes that;
 - (i) The information they do and will provide regarding the User account is and will be correct, up-to-date, valid, and complete, and they will immediately meet the requests sent by İş GYO (Is REIC),
 - (ii) While opening an account, they will not act on behalf and account of any other person or institution other than the legal entity they represent,
 - (iii) They will not share their account and information of their account with anyone,
 - (iv) They accept liability for ensuring the privacy and security of their account and for all activities that occur on or through their account
- **2.3.** In case of unauthorized use of the user account, the user and the persons using the Site/account without authorization do not have any right to complaint, demand or action against İş GYO (Is REIC).
- **2.4.** İş GYO (Is REIC) has the right to suspend or terminate the user account for any reason, including but not limited to the following:
 - (i) Ensuring the implementation of the Terms of Use and preventing existing or potential violations of the law or the Terms of Use

- (ii) Protecting the integrity, stability, prestige or reliability of the Website and other İş GYO (Is REIC) systems,
- (iii) Defense against existing or potential lawsuits, whether or not they are essential,
- (iv) Preventing the emergence of any legal or criminal liability,
- (v) Implementation of court or administrative authority decisions.

- **3.3.** İş GYO (Is REIC) reserves the right to change, correct, update and remove the Content at any time without notice. This authority of İş GYO (Is REIC) does not constitute an obligation for İş GYO (Is REIC).

4. CONVENIENCE

We do not warrant or commit the continued or uninterrupted availability of the Website. It is possible that the Website is inaccessible or inoperable due to maintenance, modifications, changes, new features, hardware/system failures, technical problems, reasons beyond our control or unforeseen reasons, or for any other reason. You accept and declare that İş GYO (Is REIC) is not responsible if the Website is inaccessible or not fully operational for any reason.

5. RULES OF USE

5.1. We have set some ground rules to ensure the security, integrity, and reliability of the Website. Within this framework, you must comply with the following rules (and must not attempt to violate them or assist third parties to violate them):

You explicitly agree and declare that İş GYO (Is REIC) is not responsible for the operation and practices of third-party websites other than the Website and that no demand, complaint, or dispute arising from or in connection with these websites can be brought forward against İş GYO (Is REIC). - **12.2.** Istanbul (Çağlayan) Courts and Enforcement Offices are authorized to settle all claims, disagreements and disputes arising from or in connection with the Terms of Use.
